Note for TIF Districts with more than one parcel:

Tax increment captured tax capacity is calculated for a TIF District in total, it is not calculated at the parcel level. The TIF District total captured tax capacity is then allocated back to each parcel within the TIF District based on the proportion that the TIF District total captured tax capacity bears to the total current tax capacity of the property in the TIF District. That uniform percentage is multiplied by the current tax capacity of each taxable parcel in the TIF District to determine the captured tax capacity allocated to the parcel. If the District in total has captured tax capacity, then each taxable parcel in the TIF District will have captured tax capacity allocated to it regardless of whether the value on that parcel increased or decreased from the base value. The captured tax capacity is multiplied by the tax rate to arrive at the tax increment tax. As such, the tax increment on one parcel out of a multi-parcel TIF District does not necessarily reflect the development activity on that parcel, it reflects a district-wide average.
